

Login & Check-in: Once you've logged in to the NKF Meetings mobile app or web browser portal (https://cme.kidney.org/spa/courses/resource/r830-2026-spring-clinical-meetings/event/home), follow the system's prompted steps to verify your personal information and COMPLETE ATTENDEE CHECK IN.

Program Management: Within the mobile app or web browser portal, navigate to the "Program" page to review, filter, and search for sessions within the SCM program. Favorite sessions of interest by selecting the heart icon. Doing so will add the session to your personalized itinerary, making it easier to complete credit requirements later.


View from Web Browser:

Tracking Sessions and Credits: To track your credits from the mobile app, navigate to the Home menu, select the "Certificates" icon, and select the "Complete Requirements" button. From a web browser, navigate to the "Credits" tab. From the "Evaluations" page, you can review your Earned Credits. You'll find a table that lists



the accrediting body, earned, and claimed credit amounts. Track your activity by filtering the Session List to show your completed sessions, your favorite sessions, sessions specific to your profession, or sessions that are incomplete for credit retrieval.

Completing Post-Session Requirements for Credit: Once you've attended a session, there are a few steps to claim credit. SCM sessions that are eligible for continuing education credit will always require an Evaluation. Depending on the topic's accreditation guidelines, a session may also require a Pretest and Posttest to receive CE credit.

Sessions that are "Complete" will show green checkmarks for each post-session item and can be claimed for credit.

X Sessions that are "Incomplete" are missing a pretest, posttest, or evaluation and cannot be claimed for credit until those items are fulfilled.





Claiming Credits: After you've completed your session tests and evaluations, navigate to the "Certificates" tab to claim your credits. By selecting each "Claim Credits" button, a total number of your earned credits will be generated for each accrediting body. After the page refreshes, you should see your credit totals and two button options. Once you've claimed all earned credits, the "Claim" button will no longer be available.

Certificates are NOT emailed to attendees. To download your credit certificates, select each "Download" button. If you return to complete more sessions after you initially claimed credit, select the "Change" button within the necessary certificate section. Doing so will trigger the page to refresh and your Credits Claimed total to be updated. This will also generate an updated certificate for you to download.

Important Reminders: Be sure to review the messages at the top of your Evaluation and Certificate pages, as they will guide and remind you of important deadlines and items to complete.

June 22, 2026 is the last day to complete all pretests, posttests, evaluations, and to claim credit in the SCM app or website. Attendees must complete all necessary post-session items and manually select the "Claim Credits" button to officially claim their CE/CME credit by the communicated deadline.
