



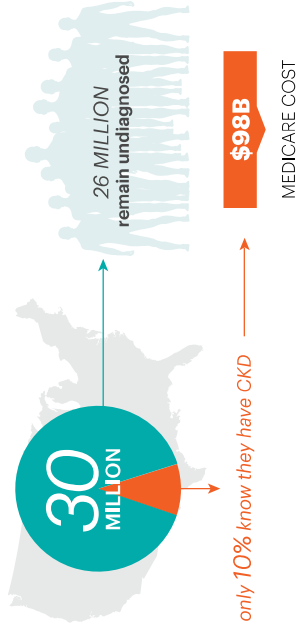

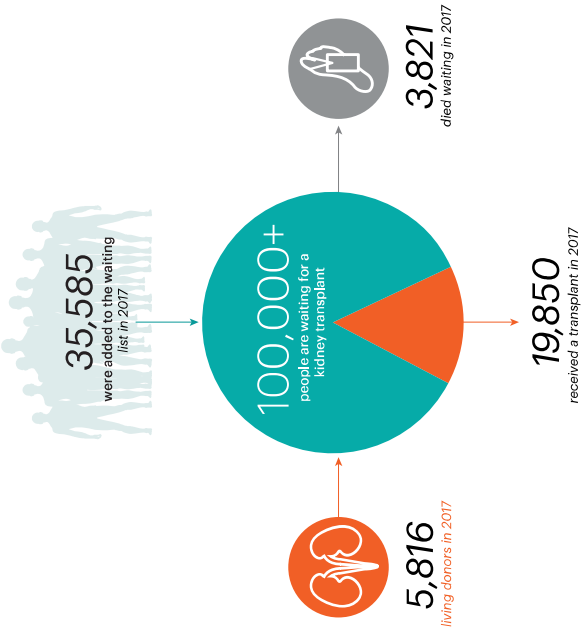

HOW CAN CONGRESS HELP FIGHT KIDNEY DISEASE?

Chronic Kidney Disease Early Detection and Management (H.R. 3867)

Co-sponsor legislation that seeks to establish a pilot demonstration program to help improve care, and outcomes for patients with chronic kidney disease (CKD). The legislation demonstrates that early detection of CKD, combined with effective and coordinated care that engages patients in the decision-making process, can not only improve clinical results but also lower healthcare costs.

Living Donor Protection Act (H.R. 1270)

Co-sponsor legislation that would prohibit discrimination in life, disability, or long-term care insurance for living donors. The bill also adds living organ donation to the Family and Medical Leave Act (FMLA).

Appropriations

Increase funding in Fiscal Year 2019 for: CDC's Center for Chronic Disease Prevention and Health Promotion to fight chronic kidney disease; the National Institute of Diabetes and Digestive and Kidney Diseases (NIDDK); and the Health Resources and Services Administration's (HRSA) Division of Transplantation and Bureau of Primary Care.
